Yongmao Holdings Limited (the "Company") announced on 1 October 2024 that the Company has launched a S\$20 million CP Facility Programme entirely in digital securities to be issued by the Company and listed on the SDAX digital platform that is operated by SDAX Exchange Pte Ltd ("SDAX Platform"), who is a recognised market operator and regulated by Monetary Authority of Singapore.

In connection with the above, the Company's third issue of Tokens under the CP Facility Programme, being YM_D003_3/SGD ("3-month Series 003 Issue"), was also launched on 15 April 2025 at an interest rate of 4.9% per annum, and which also matures on a date falling on the expiry of 93 days from the issuance of the digital tokens ("Tokens") to be issued by the Company and listed on the SDAX Platform to accredited investors and institutional investors.

Accordingly, the 18 tokens under YM_D003_3/SGD, with an aggregate principal amount of S\$180,000, issued to Mr. Tan Eng Ann, have been fully redeemed by the Company on 17 July 2025.
