Yongmao Holdings Limited (the "Company") announced on 1 October 2024 that the Company has launched a S\$20 million CP Facility Programme entirely in digital securities to be issued by the Company and listed on the SDAX digital platform that is operated by SDAX Exchange Pte Ltd ("SDAX Platform"), who is a recognised market operator and regulated by Monetary Authority of Singapore.

In connection with the above, the Company's first issue of Tokens under the CP Facility Programme, being YM_D001_3/SGD ("3-month Series 001 Issue"), was also launched on 11 October 2024 at an interest rate of 5.30% per annum, and which also matures on a date falling on the expiry of 95 days from the issuance of the digital digital tokens ("Tokens") to be issued by the Company and listed on the SDAX Platform to accredited investors and institutional investors.

Mr Sun Tian had subscribed for 9 Tokens with an aggregate principal amount of S\$90,000 under the 3-month Series 001 Issue.

Subscription for the 3-month Series 001 Issue had closed on 11 October 2024. On 11 October 2024, Mr Sun Tian was issued 9 Tokens under the 3-month Series 001 Issue.
